## 6. Neighbourhood Plan: Report from Cllr James Good

The referendum will be voted on 7<sup>th</sup> May 2021 alongside the local elections.

A flyer has been sent round to all houses as a reminder about the NP, the flyer consisted of the information statement produced by Buckinghamshire Council.

## 7. Kimble Stewart Hall: Report from Cllr Delia Burton

Hall still not re-opened and first time it will be used will be for the local elections, the hall still has all the Covid secure signage, one way system, hand gel, etc in place so it should not be too much of an onerous task but further information is awaiting from Buckinghamshire Council.

The new sign is up and has received very positive feedback, the planters are in-situ and Rob Mill has ordered the plants which should be in in a couple of weeks.

## 8. Annual Parish Meeting and Annual Meeting of the Parish Council – 12<sup>th</sup> May 2021 – confirm times and restrictions at the Hall to meet Covid criteria.

As from 6<sup>th</sup> May 2021 we are not legally allowed to meet remotely so both our AMPC and APM will need to be in the main hall with socially distancing adhered too. The Annual Meeting of the Parish Council will take place at 7pm followed by the Annual Parish Meeting at 8pm.

**9. B4009 – Proposed course of action on safety in this area – Cllr James Cripps**

Councillor Cripps presented his report on this issue and it was agreed that we should request a feasibility study from TfB via the Community Board so we can benefit from 50/50 funding. They will then look at all the possibilities here and come back to us with costs and schemes. It is unlikely they will suggest a reduced speed limit on this road but we will keep pushing for this.

**10. Marsh Kerbing Project – Update from Councillors Good and Williams**

Cllrs Good and Williams met with our local area technician, James Tunnard, and walked through Marsh Village so James could see the issues. Improved signage, re painting of road markings, carriageway edge repair and white line painted on the edge of carriageway at strategic places were suggested. We will now apply to Community Board and PACS Team for funding and scheme brief,
