A pre-planning application has been received regarding installation of replacement masts at Old Rifle Range Farm, it was agreed that a favourable response would be returned on the provision that the masts are no taller than the existing.

**6. Public Footpath No 29 Great and Little Kimble diversion Order**

After discussing this item with members of the ROW team in attendance, and with the support of Cllr Carroll, the Parish Council unanimously agreed to continue with their objection to this order.

**7. Defibrillators**

*To resolve to purchase one or several for use around the Parish and their location(s) and agree a cost*

A budget of £1000 was agreed for this project. Locations agreed to be Outside the Village Hall and The Swan.

**8. Request from the Princes Risborough Community Bus for a grant towards a new bus**

It was unanimously agreed that £500 would be granted to this worthy cause in the new Financial Year.

**10. Draft Budget review for 2015/16**

*Review of budget and projects within the Parish for FY15/16*

It was unanimously agreed to Precept £30K, a rise of £5K from the previous year, to enable purchase of defibrillators, upgrade of playground equipment and highway improvements to Church Lane and Marsh.

- Solar lighting at Bus Shelter – Cllr Redding reported that this would not be able to be installed due to high cost and cheaper equipment not being up to the job.
- Councillor Austin will draft an open letter to be produced as an insert to go out with the newsletter reminding the Parish about forthcoming elections.
- Network Rail are holding an Public Consultation regarding the proposed upgrade of all crossings along the railway line between Aylesbury and Princes Risborough. This is part of the East West Rail improvements scheme.
- It has been reported that more soil is being deposited in the field adjoining Lake Adams, the Clerk will contact WDC and TfB to find out if this breaches any planning permissions.
