## 5 Various BCC highways planning matters, including footways, footpaths, VETs (Village Entry Treatments), Vehicle Activated Sign/s and Buckinghamshire County Council Grass cutting.

The County Council has agreed to support the Parish Council in the provision of amber flashing light warning system outside the school in Church Lane

The Council is much concerned about the very slow progress in repairing potholes after the winter damage

**6 To review the applications for the parish councillor casual vacancy and decide which applicant to co-opt to the council.**

The Council unanimously agreed to appoint by co-option Martin R Saunders to the casual vacancy for Parish Councillor

**7 To determine any further action on the matter of The Gypsy and Traveller proposals from Wycombe District Council**

After a lengthy and detailed discussion the Council agreed that TM would represent the Great and Little Kimble cum Marsh Parish Council at the Wycombe District Council Planning Committee meeting on the matter of an application from owners of "The Willows", Bishopstone Road, Marsh

AC reported on ongoing maintenance costs of KSH and the limited possibility of raising income  
The Council agreed to obtain details of the legal transfer/donation made in the 1920's when the hall was originally built with a view to a longer term solution to the provision of community facilities in the parish

***d) Arrangements for the Annual Parish Meeting on 12<sup>th</sup> May 2010***

The APM was confirmed on the 12<sup>th</sup> May and the Clerk agreed to contact Pam Priestley and Paul Rogerson to speak on this occasion. The Clerk agreed to ensure this event was well advertised

***e) Inscription on war memorial.***

AC agreed to liaise with SW to agree an inscription.
