The Clerk has received a reply from BCC about options for crossing facilities here and the will contact the Headmistress of the School to ascertain if the School has any plans to address this and invite her to discuss the matter with the PC.

c) *Report from Clerk*

- Playground
All RoSPA recommended remedial works have been carried out.
- Litter/Dog waste signs on The Green outside the Swan PH
WDC have placed numerous 'Pick up after your dog' stickers around the Parish and it was felt that more of the same here would not help. Children's posters would be more effective.
- Litter pickers
We can get 10 litter pickers from Bago Ltd for £150, the Clerk will order.

d) *Reports from Councillors*

- It was noted that work at the Gypsy and Traveller site at Marsh Lane was underway with partial demolition of existing barn. Cllr Good will check this was part of the planning permission.
- The Clerk was asked follow up with BCC about what action they have taken regarding the concrete lay-by that was constructed in Marsh
- The Footpath along the A4010 has still not been cleared, both the Clerk and Cllr Redding have been asking for a site meeting with BCC Technician to discuss.
- The Clerk will ask for an update on the affordable housing development for the next meeting.
- Speeding through Marsh has once again been highlighted. It was suggested that installation of speed tubes to get a more accurate indication of speed would be appropriate. Installation of such tubes cost £380 + VAT from BCC but may be cheaper to go to a private company. The Clerk will request the repainting of the 'Slow' sign prior to the bridge at Marsh.
